Please remember that all perpetual trophies should be returned to any member of the Management Committee by 1st September 2016 - failure to do so could result in a fine being levied or points being deducted at the discretion of the Management Committee.

2016 looks like a promising start for Hinstock CC, with the help of the SCCL and their Small Grant Scheme they have now vastly improved the facilities at their club and now teams in Division 4 can look forward to making the trip to their club.





"Hinstock CC have had an old portacabin for dressing rooms for approximately two decades and over time this facility had deteorirated. In winter 2014/15 the club officials decided that essential maintenance work was required to repair and enhance the clubhouse.



Thanks to the goodwill of sponsorship of local businesses in the area and to the grant received from the SCCL, we have been able to clad the clubhouse, add an outbuilding to store cricket equipment, replace windows, refurbish the toilet, repair the roof, all of which has been done by the help of our players." said Kevin Goucher, Club Spokesman.

Improvements to Facilities & Small Grants Scheme

Over the last year, a number of clubs (like Hinstock CC) have taken advantage of the League's Small Grants Fund, set up in association with the Shropshire Cricket Board, to upgrade their facilities — so far the scheme has provided funding for a range of improvements including clubhouse refurbishment, covers, rollers, sightscreens and new nets.

There is still a limited amount of money available so all clubs who haven't already received funding and have a scheme that they think the League can help with are encouraged to apply as soon as possible. Please note that grants are limited to £500 per club and the League won't consider applications for funding for pitch improvements themselves (e.g. fertiliser, loam etc.) but would consider applications for help to fund new machinery.

Law Appreciation Course

SCCL Declaration

In accordance with clause 3(e) of the SCCL Constitution, all clubs are again required to sign a Declaration governing their conduct & obligations as SCCL members before the start of the 2016 season

This Declaration should be completed & returned to League Secretary Brian Kitson ideally on or before the pre-season Captains Meeting on Monday 18th April 2016 or not later than 12 noon on the first Saturday of the season.

If a member Club fails to meet this deadline, no points will be awarded to any of that club's teams for games played before the signed Declaration is received.

Clubs should note that points deducted for this reason will not be reinstated after the Declaration has been received, i.e. they will be lost permanently.

A copy of the Declaration, duly signed and dated, must be displayed prominently in the club pavilion or clubhouse for all club members, both playing and non - playing, to see. (It is attached to this Newsletter)

Constitution, Insurance & Child Welfare Officers

The recent Facilities Audit conducted by the League threw up some worrying results, some clubs don't have a formal Constitution, the correct level of insurance or even a properly trained Child Welfare Officer!

Clubs are reminded that that it is a condition of their membership of the League to have the following in place;

- •A formal written Constitution.
- •Public Liability Insurance cover to a minimum of £5million.
- •At least one trained Child Welfare Officer (ECB good practice now recommends that clubs should have two trained welfare officers.)

The League will be ensuring that all clubs meet these requirements during the coming season so if your club doesn't, please act on this immediately.

The League advises all clubs to be extra vigilant at this time and ensure that all possible security arrangements are made and your insurance provision is adequate.

Clubs should be aware that with effect from the 2016 season all home teams will again be responsible for the provision of two match balls and free teas.
