TREASURER'S REPORT 2016/17

With the financial support of our League sponsors, Henshalls Insurance Brokers, your Management Committee have been able to continue to fund trophies for Player of the Month & Players of the Season, umpire training, a yearbook & an improved website during the 2017 season.

In addition SCCL's agreement with the Shropshire Cricket Board (SCB) to jointly fund a small grant scheme (SGS) to help finance facility improvements for our smaller clubs, who are not readily able to access other grant funds, was extended with both SCCL & SCB contributing a further £2,000 each into the fund. During 2017 some £1,200 of the original £4,000 was allocated for a range of facility improvements leaving a further £2,800 available for clubs to apply for.

With the support of our League sponsors your Management Committee embarked on the above initiatives with the intention of maintaining our reserves at a figure of around £7,000 & posted a small surplus of some £470 during 2016/17, thereby maintaining our general cash reserves as at 31/10/17 at £7,462.

We were unable to find a replacement sponsor for our T20 competitions during 2017 but have secured sponsorship from solicitors, Aaron & Partners LLP, for those competitions in 2018.

Following the increase in annual subscriptions to £50 per team at the 2015 AGM I do not propose to make any further increases in subscriptions for the 2018 season & so we will retain our position as the League with the lowest annual subscriptions of the BPL feeder leagues.
